Charges for boats/yachts calling up to 4 weeks include the supply of water (200L) and electricity (5A)

The declaration of the ship's arrival at the Port must be made at the port office by the person in charge. The extension of a stay must be immediately reported to the port office.

Anyone occupying a mooring is required to comply with the regulations and instructions of the Port (displayed at the Port office).

The annual flat rate is imperatively payable in two semesters within a maximum period of one month following the invoice date. If payment is not received within this period, the annual flat-rate rate will be considered null and void, and the fee will be recalculated according to the daily rate.

The rate applicable for any catamaran corresponds to the rate applicable for a position of corresponding length, multiplied by 1.5 (i.e. increased by 50%).

The applicable rate for any Motorised Water Craft (MWV, e. g. jet skis) corresponds to the rate to moor its launching platform moored at the quay. No jet ski is allowed to be moored without a suitable platform.
